3	Liverpool School of Tropical Medicine (LSTM) JP from the LSTM provided a presentation on the experience of moving away from being	
	a department as part of the University of Liverpool to becoming a Higher Education Institute in own right. She explored the challenges of starting to build the service from the ground up, developing the library systems (OCLC's WorldShare Library Management System, Ebsco Curriculum Builder to manage reading lists student support, virtual learning environment on Blackboard, interlibrary supply using Clio, Kopernio plug-in for Chrome was also recommended to help link ILDS at point of search). There was also a need to design all the policies and procedures and re-configuration of both the library and the workforce structure. Talis is recommended by both ZGM & LC for managing the reading list. As part of the discussion ZGM updated the group that JISC has signed a deal which allows universities to purchase through JISC Collections. ZGN agreed to share the update with the group. The deal will allow all students and academics to install the software on their own personal devices at no extra costs. Key lessons learned from the experience include getting high level buy-in to help develop the service and fund the changes, make sure you get your staff resourcing right and use stakeholder feedback to make the case to the powers that be. 	 The Brain Trust The Service Manager has been made redundant after recent review of service. This year's focus will be on the charity's role around social prescribing. Increased demand for benefit applications support and financial advice. New research has started on supporting people with early diagnosis motor neurone disease to help them maintain an active life and continuing activities they enjoy and also reviewing how neurological disordered were portrayed in the past as a forum for discussion about change. 	 University of Liverpool Just started a new course to train 40 advanced clinical physicians (Level 7) which has library support embedded from the beginning of development. 	 Aintree University Hospital Trust A training needs analysis has been completed and new library courses are underdevelopment using Panopto and Powtoons. Courses include academic writing, study skills. TO reminded the group that some training is available through the Knowledge for Healthcare Learning Zone. Courses are being made available to students using the full Blackboard VLE, but a platform is being developed for NHS staff using the free version of Blackboard (very limited with statistics, can only count page accesses).

- Library outreach service is linking in with Primary Care & Health Sciences Centre at Keele University to deliver satellite Critically Appraised Topic support to local GPs
- Work on virtual reality has been delayed due to withdrawal of stock prior to a relaunch by Microsoft in June 2019. We have been liaising with University of Chester & Reaseheath College around a local VR support network in the area. Recently visited Reaseheath to view a demo of the Anatomage table. Decision has been taken no to pursue that avenue.
- A briefing paper is being prepared to look at local partnering with NHS@70 to collect local shared stories of staff and public with a view to research the use of stories as a driver for service improvement. The team will be visiting the Trust on the same day as the Human Library event on 19th June. JI has recently been discussion with the NHS@70 Team around capturing stories of people with neurological conditions.
