	W Cheshire – LE is based within Business Intelligence but is not certain of the future of library services. There is still no Director in place and the organisation is very unsettled. GS will be taking voluntary redundancy in March. In the meantime she is also working with Bridgewater Trust for 2 days per week.

	Aintree – Rachel Bury has been replaced by Lisa McLaren. Plans are being made to redesign the Clinical Sciences Centre over the next 2 to 3 years. The library could relocate to the ground floor allowing 24 hour access. Also developing a fiction collection to attract non-clinical staff.				
	Warrington – Have launched 'Lunch & Learn' sessions for students. Students share knowledge on a specific theme over lunch. First session was on revision techniques; future sessions are planned for dementia, pressure ulcers and leadership. Starting to record members of Trust staff on Soutron as a resource. This is to develop a skills/knowledge database of staff expertise. Tom McMillan is a new member of staff and is currently redesigning the website.
